Amenity or Activity	Status	Controls Measures and Restrictions
Tennis	OPEN	Play with members of your immediate household only . No equipment rentals available at this time. Physical distance from other members on the courts - At least 2 meters but there is enough space on the courts to provide more.
Pickleball	OPEN	Play with members of your immediate household only . MLRA Pickleball nets will not go out. Play over tennis nets permitted. No Equipment rentals. Physical distance from other members on the courts - At least 2 meters but there is enough space on the courts to provide more.
Basketball	OPEN	Play with Members of your immediate household only . No Ball rentals. Maintain Physical distance from members outside your immediate household.
Beach Volley Ball Courts	CLOSED	Area closed and marked off.
Playgrounds	OPEN	CAUTION - High Touch Area . Surfaces will not be sanitized by MLRA. Use at your own risk.
Green spaces	OPEN	Passive play with members of your immediate household only . Maintain Physical distance from members outside your immediate household. No gatherings permitted at this time.
Boats		
- Lake Shore Boats	OPEN	Members of immediate household only . No docking boats on MLRA beach or MLRA boat dock. Access to MLRA facility via boat not recommended at this time. Maintain Physical distance from members outside your immediate household.
- Lake Access Boats	OPEN	Members of immediate household only . No docking boats on MLRA beach or MLRA boat dock. Access to MLRA facility via boat not recommended at this time. Storage of boats at access way docks prohibited. Maintain Physical distance from members outside your immediate household.
- Other Boats (members bringing in boats through park gate)	OPEN	Members of immediate household only . Kayaks, SUP, canoes and small boats permitted for use at this time. Kayaks and SUP's can be launched off the beach but not stored there. Launch other boats off boat ramp or MLRA dock. No pedal boats or row boats at this time. Maintain Physical distance from members outside your immediate household.
- MLRA Boat Rentals	CLOSED	All Boat rentals are closed at this time.
Fishing		
- Private Boats	OPEN	Members of immediate household only . Maintain Physical distance from members outside your immediate household.
- Shoreline	OPEN	Maintain Physical distance from members outside your immediate household . Do not share rods or supplies with other members.
- Fishing Pier	CLOSED	Area closed due to confined space and touch points. Marked off with barricade.
Swimming	OPEN	Maintain Physical distance from members outside your immediate household . Beach Water sampling has been postponed by AHS but we will sample using private labs.
Beach	OPEN	Physical distancing of 5 meters if lounging. Additional space must be maintained so members can lounge comfortably and move around as needed. Limits may be implemented at any time.
Washrooms and building	OPEN	Open with Restrictions . Access building via West doors only, one door entrance only and the other exit only. Limits on # of people per washroom. Water fountain and vending machines closed. No loitering. Enhanced cleaning protocols. Maintain Physical distance from members outside your immediate household. Signs will be posted.
Shelters	CLOSED	Unavailable for rent or use at this time. Marked off with caution tape.
BBQ pits	CLOSED	Cooking prohibited. All cooking devices are prohibited at this time.
Picnic Tables	OPEN	CAUTION - High Touch Area . Surfaces will not be sanitized by MLRA. Use at your own risk.
Park benches	OPEN	CAUTION - High Touch Area . Surfaces will not be sanitized by MLRA. Use at your own risk.
Showers	CLOSED	Closed at this time due to touch points and sanitization challenges.
Equipment Rentals	CLOSED	No Rentals whatsoever.
Lake Shore Docks	OPEN	Members of immediate household only . No guests.
Lake Shore Trampolines/inflatable structures	CLOSED	Water trampolines and other inflatable structures are Not permitted at this time.
Lake Access Docks and Paths	OPEN	Maintain Physical distance from members outside your immediate household . Only members from one immediate household permitted per dock at one time. No Guests.
Guard House Entrance	OPEN	Access the facility via the Guard House only . Modified procedures implemented for the safety of staff and members. <ul style="list-style-type: none"> - Plexiglass barrier between security staff and members - Do not need to handle card to scan - Signs and markers to direct members - Liquid Hand Sanitizer available at West guard house window - Maintain Physical distancing as instructed - Exit gate left open to eliminate push button
Main Office	OPEN	Open to answer phone calls and emails. Also open for in person appointments with restrictions and enhanced cleaning controls in place. Appointments can be made by calling 403.257.1657 or email office@mlra.ca . We continue to process cheques that are dropped off or mailed.
Other Rules Implemented or Modified for COVID -19		<ul style="list-style-type: none"> - NO GUESTS permitted in the facility, lake, or any other MLRA property. No Exceptions. - Gatherings are Not permitted at this time. - The minimum age a member is permitted to enter and remain in the facility without a parent is sixteen (16). - Always maintain a physical distance of at least 2 meters from anyone outside your immediate household.
